

CALL FOR PROPOSALS—INSTRUCTIONS

The Greater Montreal Climate Fund (FCGM) has announced its first call for proposals, aimed at reducing greenhouse gas emissions in the Greater Montreal Region (CMM).

In this call, FCGM is looking to grant, as part of its charitable activities, to innovative and system-focused projects which help communities reach climate targets of and in the 82 municipalities of Greater Montreal. We are in particular looking to support activities and teams which meaningfully impact and accelerate GHG reductions in a spirit of just transition and equity, in our region.

To be eligible for a grant, proposals must:

- Happen in a CMM-member municipality. (To confirm whether your service area is a member, please check www.cmm.qc.ca.)
- Entail real GHG reductions either measured or realistically projected, over the next least ten years;
- Be replicable, and have or demonstrate a solution which can scale up in the region;
- Produce data which is accessible to the public in some form;
- Show a co-benefit for the community (e.g. health outcomes, climate resilience, equity, reconciliation, knowledge building or transfer, behavioural change, etc.);

We favour proposals showing community involvement and support in some form; if you intend to present a proposal in partnership with another entity or community group, the main partner carrying out the work must be based in, or have activities in, the CMM.

Please note that FCGM does not fund activities of political parties, lobbyists, or activities to lobby federal political parties.
